#### 1. Election of Chair

#### 4. Declarations of Interests and dispensations

#### 8. Plan Development

The Council's NDP consultant had recommended that the draft NDPpolicies be reviewed in light of the changes at agenda item 9 and any matters arising from the government white paper at agenda item 10. The Council were able to apply to Locality for additional funding to support this work package. It was proposed by Cllr Taylor, seconded by Cllr Pearce and unanimously agreed that the consultant is asked to detail the work package and that the Deputy Clerk submits the grant application and that

- **10.** It was noted that new **Use Class Change Orders** had come into effect on 1 September and their impact on the emerging NDP were considered.

Members had been provided with briefing notes to assist their consideration of the consultation and this would be an agenda item for the next meeting.
