

Register Of Interest for Mr John Sillett

I, Mr John Sillett, a non-councillor member appointed to a committee of Lowestoft Town Council, set out below under the appropriate headings my interests, which I am required to declare under the Localism Act 2011 and the Council's Code of Conduct.
