Key issues discussed/noted were:

The meeting was sparsely attended and there were a number of apologies given. Chaired by Genevieve Christie of First Light Festival CIC (GM). Amongst those in attendance were: Jo Leverett (FLF CIC) (JL), Via Josh Freemantle Access Community Trust (JF); via Microsoft Teams – rep from CEFAS. Cllr Sonia Barker LTC representative (SVB).

- **Festival Debrief:** GM reported that there were c40,000 people who attended over the weekend of 17/18 June 2023 (this was an increase on 2022). Initial findings:-
- Increase in the number of traders
- Increase in people from outside seeking accommodation.
- Double the number of people parking vehicles in Lowestoft car parks. SVB suggested looking at FL volunteers and how they had travelled into Lowestoft as many had walked/cycled.
- 40% number of passengers on trains after extra trains provided from Ipswich/Norwich.
- 40% increase in electricity costs.
- Very good feedback from performers/participants/audiences following changes to timings.
- The FL Parade was very well received from The Marina Theatre to Claremont Pier. A large number of young people were involved.
- FL Volunteer feedback was positive.
- GM reported that the official First Light report of the event will be completed by early September. SVB asked that the report be sent to LTC by 18/19 September 2023 in time to go out with the LTC full council Agenda on the 19.9.23. for the meeting on the 26.9.23.
- Environmental Responsibility: First Light is working towards a benchmark stipulated by the Arts Council, re improvements to

	rubbish collection; increased use of solar power in Kensington Gardens; Environmental Responsibility Task Force festival wardens from the 17th/18th June 2023, and their findings will be in the upcoming report. • Lowestoft Town Council will be contacted re a representative to join the Environmental Task Force. • An Environmental Task Force Action Plan is to be draw up before next year's 2024 First Light Festival. • There is an increasing link between First Light and CEFAS. • A representative from the First Light Steering Group will report to the First Light Directors' Board to increase communication. • Next Year's Theme for the 22 nd /23 rd June 2024 is still in the planning stage and will be announced soon.
