Suffolk County Council – Lowestoft Area Transport Plan

Introduction

There is a statutory requirement for Suffolk County Council to prepare a Local Transport Plan. The 2025 – 2040 Plan is currently out for consultation. For this Plan SCC have also prepared a suite of Area Plans (15 have been prepared), including one for Lowestoft.

There are five objectives for Lowestoft Plan, these are:

- Enable active travel to be the default choice for shorter trips
- Improve bus punctuality and reliability
- Improve the integration of modes
- Maximise growth opportunities
- Support town centre economies

The Area Plan also includes an Implementation plan for Lowestoft, outlining the county council's priorities for investment over the next five years. For Lowestoft these priorities are:

- i. Local Cycling & Walking Infrastructure Plan (LCWIP) High Priority routes = £1m
- ii. Modal integration at transport hubs = £300k
- iii. Town centre walking & cycling improvements = £400k

The LTC Passenger Transport Working Group met on 7th November to consider a response to the Area Plan for Lowestoft. This DRAFT response is recommended to the CEEC for consideration and amendment prior to submission. **The SCC Plan is out for consultation until 25th November 2024.**
