This initiative has been hugely successful as we have been able to welcome many new players to the Denes site and provide them with the loan of the equipment that the grant provided for. To extend the campaign of supporting free court usage we would like to be able to provide tennis rackets in a similar initiative for loan to all visitors to the tennis courts on the North Denes. We have contacted Yonex for additional support on this project, and they have agreed to a substantial discount which reduces the price from £700 to £504
