MINUTES

Present (in person): Cllrs Wendy Brooks, Alan Green, Peter Knight (Chair) and Peter Lang

In attendance (remotely via Zoom): Sarah Foote (Deputy Town Clerk)

Public: There were no members of the public in attendance (either in person or via Zoom webinar). Two Officers from Suffolk Highways were in attendance at the meeting.

160. Welcome

The fire evacuation procedure and public right to report were explained, and the meeting was welcomed.

161. Apologies for absence

Apologies were received from Cllr Pearce and Cllr Newsome. Cllr Green proposed acceptance of the apologies received; seconded by Cllr Lang; all in favour. Cllr Taylor was absent.

162. Declarations of Interests and dispensations

Cllr Green declared a non-pecuniary interest in application DC/21/5687/FUL in relation with this association with Lowestoft Football Club.

163. The draft Minutes of 18th January 2022

Cllr Lang proposed acceptance of the minutes; seconded by Cllr Brooks; all in favour.

164. Any advance comments from the public on any matters on this agenda

165. Highways

Various matters were raised with the Suffolk Highways Community Liaison Engineers and summarised as follows; Councillors were also directed to the Suffolk Highways Operational Plan for assessment criteria as a tool for determining if concerns met the defects criteria or not.

- Hollow Grove Way (Cowslip Crescent and Yarrow Drive) – extension of yellow lines to stop on-street parking near junctions and possibility of replacing grass verges with parking bays
- Gainsborough School, Gunton Avenue and Gainsborough Drive - parking
- Corton Road - Cycle Lane Markings – faded cycle lane lines.
- High Street/Rant Score – condition of surface on speed table .
- Marine Parade/ Cliff Road Speed Tables - condition of surface
- London Road / Carlton Road junction - condition of
- Saltwater Way / Victoria Road - Vegetation over cycleway
- Normanston Park to Peto Way – overhanging vegetation
- Parking Restriction Requests – in general, it was noted that the best approach would be for the Town Council to agree a list of locations for additional or new yellow lines and these be submit to Suffolk Highways for consideration as one traffic regulation order application.
