#### **MINUTES**

#### 93. Welcome

The fire evacuation procedure and public right to report were explained, and the meeting was welcomed.

# 94. Apologies of absence.

Apologies were received from Cllrs Le Grice, Pearce, Green and Barker. Cllr Lang proposed approval of the apologies received; seconded by Cllr Newsome; all in favour.

#### 95. Declarations of Interests and dispensations.

a. To receive declarations of Disclosable Pecuniary, Other Registerable and Non-Registerable Interests from councillors on items on the Agenda.

### 96. To consider the draft Minutes of Tuesday 4 October 2022.

Cllr Brooks proposed approval of the minutes; seconded by Cllr Lang; all in favour.

#### 97. Public Forum

a. There were no members of public either in person or via Zoom.

## 98. Highways

To consider highways matters with Suffolk Highways Community Liaison Engineer — Wayne Smith from Suffolk Highways was present and spoke to members on his role within Suffolk Highways. Cllr Brooks raised issues about the state of pavements in Lowestoft and temporary work that was carried out of a poor standard. Cllr Newsome also raised the issue of temporary repair works done and the standard of the work of these repairs. Cllr Brooks also mentioned other roads that were in a poor state such as St Peters Street, Ipswich Road and Historic High Street. Mr Smith suggested that the online reporting tool should be used to report all highways issues and that local county councillors should be contacted to provide funding of road repairs. Mr Smith added that there were no planned major highway schemes in place due to budget constraints. Mr Smith would provide the scheduled report of road dressing works when available.

Cllr Brooks raised the issue of yellow line restrictions in Saturn Close and asked if this could happen at other schools.

Mr Smith suggested enquiring about the community self- help scheme. Mr Smith spoke about the possibility of volunteers and/or LTC Officers working together to clear hedgerows or clean road signs and confirmed that Suffolk County Council had a small budget for training, PPE and other equipment to support this work.

Cllr Knights proposed that the Committee considered this scheme at a future meeting; Cllr Lang seconded; all in favour.
